








# How to sign the General Terms and Conditions

In this document we present two options to sign the General Terms and Conditions (GT&C).

## Option 1: Photo or Scan

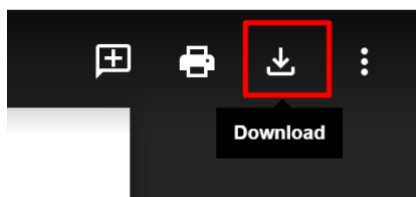
You print out the following three pages of the GT&C, complete the indicated fields and after signing it, send a scan or photo to EUROSPINE ([spinetango@eurospine.org](mailto:spinetango@eurospine.org)):

<p style="text-align: right;"></p> <p><b>GENERAL TERMS AND CONDITIONS OF THE EUROSPINE SPINE TANGO REGISTRY</b> (Formerly labelled AGREEMENT)</p> <p><b>BETWEEN</b></p> <p>EUROSPINE, the Spine Society of Europe c/o Judith Reichen Schind Schaffhausen 16 8200 Olten Zurich Switzerland (the "EUROSPINE")</p> <p>and [Your address]</p> <p>(the "Participant") (each a "Party" and together the "Parties")</p>	<p style="text-align: right;">12</p> <p>file) arising out of or in connection with the Participant's use of the Services and/or Documentation other than in accordance with the provisions of this agreement, provided that:</p> <ul style="list-style-type: none"><li>- the Participant to give prompt notice of any such claim; and</li><li>- EUROSPINE provides reasonable co-operation to the Participant, at the Participant's expense.</li></ul> <p>If EUROSPINE requests Participant to defend the claim, including, at EUROSPINE's choice, to take over the party position of EUROSPINE, to represent it in any kind of proceedings, as provided by the rules of procedure applicable to the proceedings in question, or to settle the claim in, at EUROSPINE's choice, Participant's and/or EUROSPINE's name, and Participant refuses any such request for no reasonable grounds:</p> <ul style="list-style-type: none"><li>- EUROSPINE is free to conclude any settlement it reasonably deems fit at Participant's costs;</li><li>- Prior to concluding any settlement at Participant's costs, EUROSPINE shall obtain the Participant's consent, such consent not to be unreasonably withheld; and</li><li>- Participant accepts that EUROSPINE does not have to prove, in any potential claim against Participant to receive compensation as per this clause, any statement made in any judgment against it.</li></ul> <p><b>16. Third party rights</b> Nothing in this agreement shall be interpreted or construed as conferring to a party which is not a signatory to this agreement a right to enforce any term of this agreement or as conferring a right to claim to such third party provided, however, that the Host shall have the right to assert rights under this agreement directly to Participant.</p> <p><b>17. Applicable law and jurisdiction</b> This agreement, its subject matter and its validity and any disputes or claims arising out of or in connection with it including non-contractual disputes or claims, are governed by Swiss law. Participant and the Host both agree to that the courts in Olten, Canton of Zurich, Switzerland will have exclusive jurisdiction to settle all and any disputes or claim that arises out of or in relation to this agreement, its subject matter or its validity, including non-contractual disputes or claims.</p> <p><b>18. ## Option 2: Sign with Adobe Reader

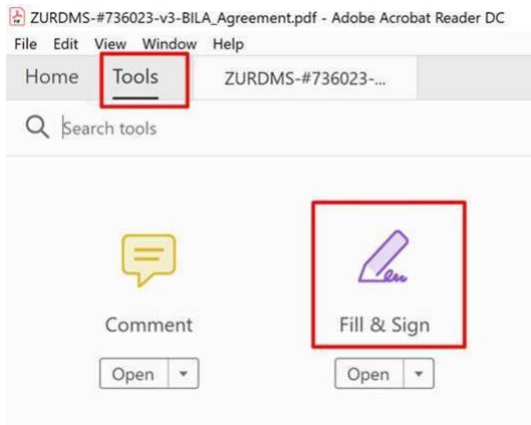
You could use the free version of Adobe Reader (<https://get.adobe.com/reader/>)

First you download the document from [here](#) by clicking "download"

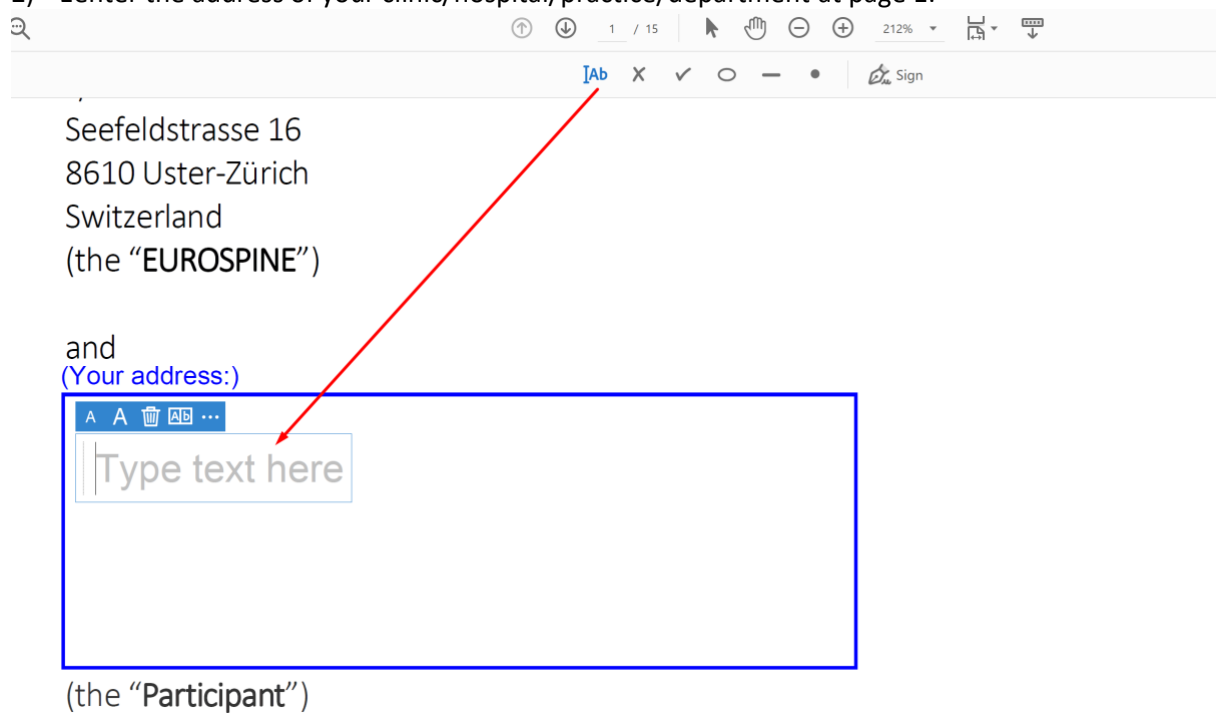


Then open the document in Adobe Reader.

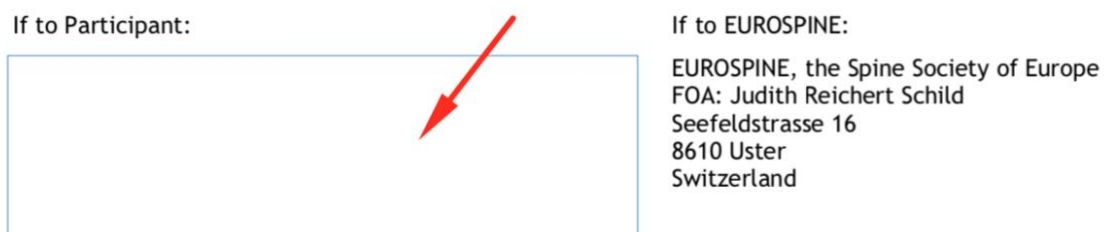
- 1) There you choose "Tools" and „Fill & Sign“:



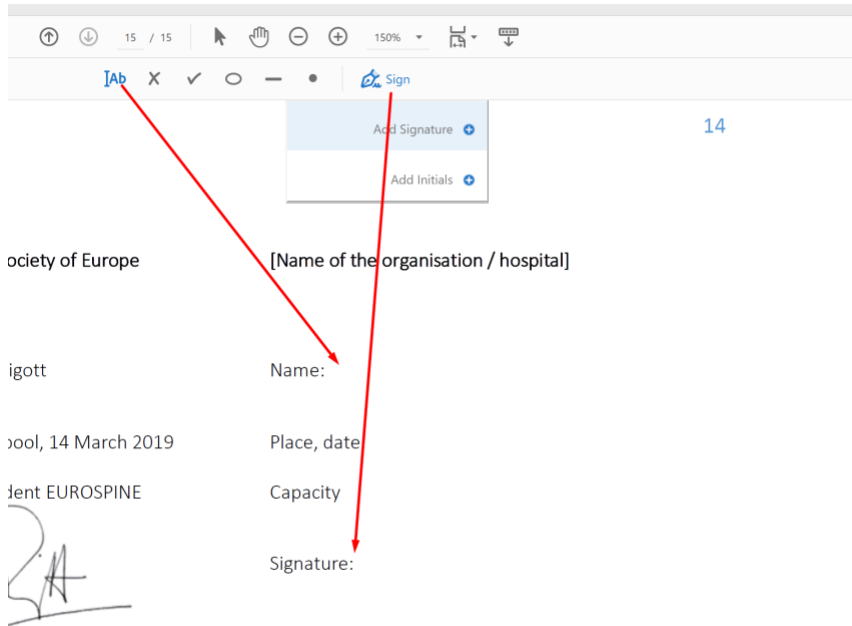
2) Enter the address of your clinic/hospital/practice/department at page 1:
